**ADDITIONAL ASSIGNMENT OF CIRCUIT AND COUNTY JUDGES  
TO THE OTHER COURTS OF THE TENTH JUDICIAL CIRCUIT FOR THE PERIOD  
BEGINNING JANUARY 2, 2018, AND ENDING JULY 1, 2018**

**WHEREAS**, it is necessary for the dispatch of business in the Circuit and County Courts in the Tenth Judicial Circuit for the following assignments to be made;


