SPECIAL ORDER

**ADDITIONAL ASSIGNMENT OF CIRCUIT AND COUNTY JUDGES
TO THE OTHER COURTS OF THE TENTH JUDICIAL CIRCUIT FOR THE PERIOD
BEGINNING JULY 6, 2020 AND ENDING JANUARY 3, 2021**

WHEREAS, it is necessary for the dispatch of business in the Circuit and County Courts in the Tenth Judicial Circuit for the following assignments to be made;

NOW, THEREFORE, I, Ellen S. 2. Judges Barber, Fegers, Green, Griffin, Grode, Kaylor, Pattey, Stamey, Swenson and Winstead to the Circuit Court of the Tenth Judicial Circuit and to the County Courts in Hardee and Highlands Counties.

3. Judge Horton to the Circuit Court of the Tenth Judicial Circuit and to the County Courts in Highlands and Polk Counties.

4. Judge Ritenour to the Circuit Court of the Tenth Judicial Circuit and to the County Courts in Hardee and Polk Counties.

These judges, under and by virtue of the authority hereof, are hereby vested with all the singular powers and prerogatives conferred by the Constitution and Laws of the State of Florida upon a judge of the Court to which he or she is hereby assigned.
