3. Regular weekend duty hours are from 5:00 p.m. Friday until 8:00 a.m. Monday. Holiday weekend duty shall begin at 5:00 p.m. on the last regular working day and conclude at 8:00 a.m. on the next regular working day. Isolated single day holiday duty shall begin at 5:00 p.m. on the proceeding day and conclude at 8:00 a.m. on the day following the holiday.
